

How to pay your Federal quarterly estimates using your EFTPS account

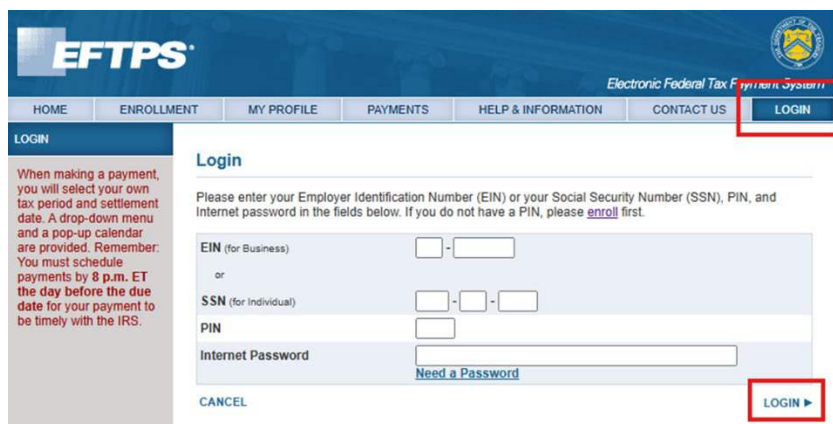
This guide will show you to pay your quarterly estimated tax payments electronically using EFTPS. Creating an account is required to make tax payments. If you do not have an account set up, please refer to the How to Register with EFTPS guide.

PLEASE NOTE:

- If you do not receive your registration PIN in the mail before the deadline of your payment, you can make a payment over the phone at 800-555-3453. **Phone payments must be completed 24 hours before the deadline.**
- Your EFTPS account will **deactivate after 13 months of inactivity**. If this happens, you will need to re-enroll and receive a new PIN in the mail to complete the registration process again.

Step 1: Navigate to the EFTPS website: <https://www.eftps.gov/eftps/>

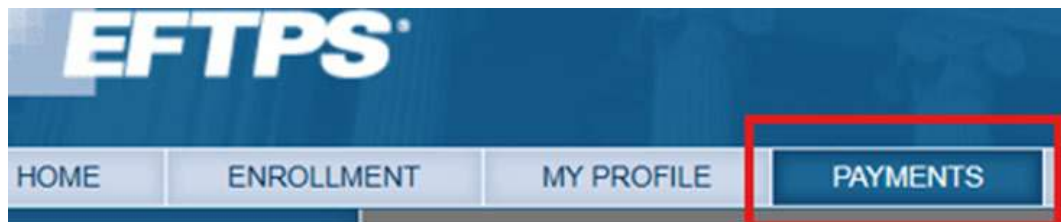
1. Hit Login on the top right.
2. Enter your EIN or SSN, PIN, and Internet Password
3. Hit Login on the bottom right.

Step 2: Initiate your payment

1. Hit **Payments** tab on the top bar.



2. Enter **Tax Form Number** in the box **OR** select from the drop-down menu (completing both will cause an error message).
 - a. This form number will be your tax return type i.e. 1120 Corporate Income Tax Return
3. Hit **Next**.

Tax Form Selection

Failure to pay employment taxes could result in a civil injunction or criminal prosecution, or in a responsible person being held personally liable for the trust fund portion of the taxes.

Step 3: Enter payment details

1. Enter the **Payment Amount**.
2. Enter **Year** under Tax Period.
3. Choose a **Settlement Date**.
 - a. Q1 is due April 15th
 - b. Q2 is due June 15th
 - c. Q3 is due September 15th
 - d. Q4 is due December 15th (businesses) or January 15th (trusts)
4. Confirm **bank account**.
5. Hit **Next**.

Business Tax Payment

Please enter the tax period year and the settlement date in the fields below. A pop-up settlement date calendar is provided for your convenience.

If you select the next business date for the funds to be electronically transferred from your account, you will not be able to cancel this payment. EFTPS requires at least 2 business days' notice to cancel a payment.
